WHEN ARE TRYOUTS?

THE 2024 NEXT LEVEL TOURNAMENT TEAM TRYOUTS WILL BE HELD SATURDAY, MARCH 23, 2024 AT 1 P.M. WE, THE BOARD OF THE CHESTER PARKS AND RECREATION LEAGUE, HAVE IMPLEMENTED THE FOLLOWING SPORTS PARENT CODE OF CONDUCT FOR THE IMPORTANT MESSAGE IT HOLDS ABOUT THE ROLE OF PARENTS IN SUPPORTING THEIR CHILD IN SPORTS.

ANY PARENT GUILTY OF IMPROPER CONDUCT AT ANY GAME OR PRACTICE WILL BE ASKED TO LEAVE THE FACILITY AND WILL BE SUSPENDED FROM THE FOLLOWING GAME. REPEAT VIOLATIONS MAY CAUSE MULTIPLE GAME SUSPENSION, OR THE SEASIB FORFEITURE OF THE PRIVILEGE OF ATTENDING ALL GAMES.

PREAMBLE
