IMPORTANT NOTICE: No one will be allowed to enter front entrance of courthouse (Taylor & State St.) until after 4 p.m. on Friday. All vendors before then (after 2 p.m.) will enter at back entrance. When you have unloaded your vehicle, please move it away from entrance so next vendor can do the same. No vendor can leave early on Sunday afternoon. Both arriving early and leaving early are reasons not to be able to set up at the following year's show. A listing of floor and space locations will be posted at both the front door and basement door to help speed up set-up. Names will be posted on the floor or benches. If you request same location, we will try to accommodate this request.

I will need your signed application and check by November 1, 2022, to even consider getting the same location. Also I will need your signature on the attached Waiver Form.
