**SET UP TIME:** FRIDAY, 2-5 PM. THE DOORS WILL OPEN TO VENDORS 30 MINUTES PRIOR TO SALE STARTING TIME. (SATURDAY 8:30 AM AND SUNDAY, 10:30 AM)  
**BREAK DOWN:** THE EVENT IS OVER AT 3 PM SUNDAY. VENDORS ARE EXPECTED TO STAY SET UP UNTIL 3 PM. **(THOSE WHO DO NOT WILL NOT GET THEIR DEPOSIT BACK)** VENDORS WILL NEED TO VACATE THE SPACE BY 4:30 PM.  
**EQUIPMENT:** VENDORS WILL BE PROVIDED ONE (1) TABLES AND TWO (2) CHAIRS. ELECTRICITY IS NOT GUARANTEED. IF RUNNING AN EXTENSION CORD YOU MUST HAVE APPROVAL PRIOR TO THE DAY OF AND YOU MUST TAPE IT SECURELY IN PLACE SO AS NOT TO BE A TRIP AND FALL HAZARD.
